

## King Bio Issues Voluntary Nationwide Recall of All Aqueous-Based Products Due to Possible Microbial Contamination

**08/27/2018 – Asheville, NC**, King Bio is voluntarily recalling all of its aqueous-based products for human and animal (see website link below), within expiry, to the consumer level due to possible microbial contamination.

Administration or use of drug products with microbial contamination, could potentially result in increased infections that may require medical intervention, and could result in infections that could be life threatening to certain individuals.
